## VENDOR TERMS AND CONDITIONS

All vendors applying to participate in an event presented by /Quakertown Alive! must agree to the following terms and conditions.

1. Quakertown Alive! reserves the right to accept or deny any vendor application.
2. The event committee will assign space location to the vendors. The committee can take special requests into consideration, but there is NO guarantee.
3. All vendors are required to remain open during the entire length of the event.
  - Upper Bucks Brewfest 12PM – 5PM
4. Vendors must adhere to the set-up times.
  - Brewfest set-up begins at 8:30AM
  - Food trucks must be in their assigned location by 9:00AM
5. All structures and sundries (tents, tables, chairs, trash cans, etc...) are to be supplied by the vendor and are the responsibility of the vendor. Tents MUST be weighted or tethered securely to the ground.
6. All food vendors must display their applicable food service license. All food vendors are required to have \$1,000,000 liability insurance and supply Quakertown Alive! with a certificate naming Quakertown Alive! and the Borough of Quakertown as additional insured by August 2, 2023.
7. If Quakertown Alive! cancels the event due to inclement weather, the vendor will receive a refund upon request by either letter or email ([events@quakertownalive.com](mailto:events@quakertownalive.com)) within 30 days. Any fees that have not been requested for a refund will be considered a donation to Quakertown Alive!.
8. Vendors agree to assume all liability for and agree to indemnify and hold harmless all organizations and persons sponsoring, managing or in any other way participating in the Upper Bucks Brewfest, including, but not limited to Quakertown Alive!, the Borough of Quakertown, and personnel from any loss, claim, penalty, or lawsuit in any way arising from operation or involvement in the Upper Bucks Brewfest.
9. Quakertown Alive! reserves the right to decide if a questionable item/ service is allowable at our organization's event. All decisions are final.
10. Quakertown Alive! has permission to share images from the vendors' website and social media. Vendors may also have their and their goods' pictures taken at the event for use on the Quakertown Alive! website and social media.
11. Vendors must agree to abide by the above terms and conditions as well as supplied additional event guidelines. Vendors who do not follow rules set by Quakertown Alive! risk expulsion from the event and being banned at future events.
