The Upper Bucks Brewfest Committee invites you to apply to be a vendor at our upcoming event on August 19, 2023.

Please read over the instructions carefully and fill out the form on the second page. Keep the first page for your records.

Application Process

Vendor spaces cost \$50 per 10' x 10' space.

Only ONE business per booth space.

As the Brewfest has limited space, each application must be reviewed and approved by our committee. Please do not send in your vendor fee until you are notified that your application has been accepted.

Once you have received your email acceptance, you will have two weeks to remit your fee. Accepted forms of payment: cash, check, money order, credit card. Checks and money orders should be made payable to Quakertown Alive!.

No refunds. The committee must pay expenses and administrative costs in advance, we do not give refunds due to rain or any other reason.

Vendors MUST provide their own canopy, tables, and chairs. Tents must be secured with weights or tethered to the ground.

Unless you make a special arrangement with the committee, each vendor booth is allowed TWO people to work during the event. If you need more people to help set up or break down your tent, that is allowed.

Vendors are responsible for their own area for setup and cleanup. Trash cans are throughout the event, but it is a good idea to bring your own.

Vendors will be provided with information regarding their booth placement when they arrive at the event.

VENDOR TERMS AND CONDITIONS

All vendors applying to participate in an event presented by /Quakertown Alive! must agree to the following terms and conditions.

1. Quakertown Alive! reserves the right to accept or deny any vendor application.
2. The event committee will assign space location to the vendors. The committee can take special requests into consideration, but there is NO guarantee.
3. All vendors are required to remain open during the entire length of the event.
 - Upper Bucks Brewfest 12PM – 5PM
4. Vendors must adhere to the set-up times.
 - Brewfest set-up begins at 8:30AM
 - Food trucks must be in their assigned location by 9:00AM
5. All structures and sundries (tents, tables, chairs, trash cans, etc...) are to be supplied by the vendor and are the responsibility of the vendor. Tents MUST be weighted or tethered securely to the ground.
6. All food vendors must display their applicable food service license. All food vendors are required to have \$1,000,000 liability insurance and supply Quakertown Alive! with a certificate naming Quakertown Alive! and the Borough of Quakertown as additional insured by August 2, 2023.
7. If Quakertown Alive! cancels the event due to inclement weather, the vendor will receive a refund upon request by either letter or email (events@quakertownalive.com) within 30 days. Any fees that have not been requested for a refund will be considered a donation to Quakertown Alive!.
8. Vendors agree to assume all liability for and agree to indemnify and hold harmless all organizations and persons sponsoring, managing or in any other way participating in the Upper Bucks Brewfest, including, but not limited to Quakertown Alive!, the Borough of Quakertown, and personnel from any loss, claim, penalty, or lawsuit in any way arising from operation or involvement in the Upper Bucks Brewfest.
9. Quakertown Alive! reserves the right to decide if a questionable item/ service is allowable at our organization's event. All decisions are final.
10. Quakertown Alive! has permission to share images from the vendors' website and social media. Vendors may also have their and their goods' pictures taken at the event for use on the Quakertown Alive! website and social media.
11. Vendors must agree to abide by the above terms and conditions as well as supplied additional event guidelines. Vendors who do not follow rules set by Quakertown Alive! risk expulsion from the event and being banned at future events.
